WG 11 has reviewed your liaison statement from [SC 34 N 1601] proposing the changes in the description of the 'panose' field of the OS/2 table and conducted the detailed discussions to investigate the impact of the proposed changes. Based on our preliminary results, it appears that the proposed changes may have an adverse effect on some existing implementations and, until the effect of the changes is fully understood, we would like to postpone their implementation and conduct further studies as part of the AHG activity on Font Format Representation. WG 11 would like to invite all interested members of SC 34 to join the AHG and contribute to its work. The results of the studies conducted by the AHG will be discussed at the next 98th WG 11 meeting in November 2011, and the decision about implementing the proposed changes will likely be made at that time.
